## Private activity in water shows mixed results in 2005

The number of water sector projects involving the private sector grew in 2005, but investment flows to these projects fell considerably, according to just-released data from the Private Participation in Infrastructure Database.

In 2005, 41 projects worth US\$1.5 billion reached financial closure in 10 low- and middle-income countries. <sup>1</sup> Annual private activity, measured by number of projects, grew 10%, reaching the second highest level since 1990. Investment flows declined 30% but managed to stay within the US\$1-2 billion range of the last four years.

New private activity was highly concentrated. China accounted for 56% of investment flows and 60% of projects. Algeria followed with one-third of investment flows and 10% of projects.

In East Asia, private activity was seen only in China, except for a small treatment plant in Thailand. In China, 25 projects were granted, involving investment of almost US\$840 million. Eighteen were contracts for water and sewerage treatment plants (bulk facilities). The remaining seven brought private activity into water utilities through concession or lease contracts.

In Europe and Central Asia, private activity was reported in Armenia, Czech Republic, and Russia. In Armenia, a management contract for the city of Yerevan was granted after the previous management contact expired. In Czech Republic, a lease contract for Hradec Kralove region was granted. In Russia, three lease contracts were granted for water utilities, and a management contract for a water treatment plant.

In Latin America, private activity was limited to two concessions for water utilities (San Andres' island in Colombia and Tumbes in Peru) and two treatment plants (Chile and Colombia). The level of activity was the lowest in the region since the early 1990s.

In the Middle East and North Africa, private activity took place just in Algeria, with a management contract for a water utility in Algiers and three greenfield projects for water treatment plants. Investment commitments for these projects totaled US\$510 million.

In Sub-Saharan Africa, private activity was limited to one project: the management contract for Ghana Water Company Limited. There was no private activity in South Asia.

In summary, 25 of the 41 water contracts were for treatment plants and 16 for water utilities. By type, there were 13 concessions, 17 greenfield projects, seven lease contracts, three management contracts, and one divestiture.

In 2005, the share of canceled and distressed private water activity rose by a few percentage points to 11% of projects and 38% of investment committed in 1990-2005. Six projects were canceled in 2005: the partial divestiture of Belize Water Services, Aguas del Illimani concession in Bolivia, Taizhou bulk water contract in China, Maynilad concession in Philippines, the lease contract for Dar es Salaam in Tanzania, and Uragua concession in Uruguay. In addition, two utility concessions went under distress: the Uruguayan government formally requested the cancellation of Aguas de la Costa concession while Energie du Mali's concession for electricity and water services went to international arbitration.
